NONCONTRACT COMMERCIAL FISHING REGULATIONS

General information: All licenses for noncontract commercial fishing are sold only at the North Dakota Game and Fish Department headquarters office at 100 N. Bismarck Expressway, Bismarck, ND 58501-5095. All persons, regardless of age, must have a noncontract commercial fishing license in their possession in order to use noncontract commercial fishing equipment. Noncontract commercial fishing licenses are issued on a calendar year basis and an individual may possess only one valid license per year. The loss of the license will invalidate the license and a new license is then required. A licensed noncontract commercial fisherman may sell their catch at their residence only.

Open Season: May 15 through November 30 of each year.

Legal Equipment: Legal noncontract commercial fishing equipment shall consist of the following:

- a. Not more than **five hoop nets** with a maximum hoop diameter of four feet;
- b. Not more than 100 feet of **seine**, with a stretched mesh size of not less than 1-1/2 inches and no larger than 3 inches;
- c. Not more than **five set lines** with no more than 10 hooks per set line.

All legal equipment used by a noncontract commercial fishing licensee must have at all times permanently attached to it a valid tag provided by the Department. The entire set line, except for the ends used for anchoring, must be below the water level at all times. All set lines must be pulled and checked at least once every 48 hours.

Open Areas: Only the following areas are open to noncontract commercial fishing:

- a. That portion of the Lake Oahe and the Missouri River from where the electric transmission line crosses Lake Oahe north of Beaver Bay to the Leland Olds Power Station/UPA boat ramp (**with seines and hoop nets only**);
- b. That portion of Lake Sakakawea and the Missouri River north and west of the Four Bears Bridge to the Montana border (**with seines and hoop nets only**);
- c. The entire Yellowstone River (**with seines, hoop nets, and set lines**);
- d. That portion of the Little Missouri River lying west of the ND Highway 22 Bridge (Lost Bridge) (**with set lines only**).

Species Restrictions: The following species of fish shall **not** be taken with noncontract commercial fishing equipment: *legal live baitfish and all game fish with the exception of channel catfish*. All game fish with the exception of channel catfish caught by noncontract commercial fishing equipment must be immediately returned to the water.

License Fees

- *Hoop Nets - \$15 per net
- *Seines - \$15 for each 50 feet or fraction thereof
- *Set Lines - No charge

The NDGFD receives Federal financial assistance from the US Fish and Wildlife Service and the US Coast Guard.
