TENTATIVE Upland Game Season Opening Dates:
 Sandhill Crane - September 19. (Subject to federal authorization).
 Hungarian Partridge, Sharptailed Grouse, Ruffed Grouse - September 12.
 Pheasants - October 10 (regular season), October 3 and 4 (youth season).

TENTATIVE Waterfowl Season Dates: Based on frameworks established by the US Fish and Wildlife Service, the duck and goose seasons may open on September 26 for residents, **and on October 3 for nonresidents**. The youth waterfowl season may be held on September 19 and 20. Official season dates will not be set until late August, 2009. Call the Department at 701-328-6300, visit our website at gf.nd.gov, or consult waterfowl regulations for details.

1. LICENSING REQUIREMENTS: Nonresidents may purchase licenses to hunt upland game, fox and coyote, or unprotected birds or animals upon making application to the Department, county auditor's offices, license vendors, via the internet, or by phone (see back of application for details). Nonresidents may purchase licenses to hunt waterfowl and crane only through the Department, via the internet, or by phone. Those wishing to hunt only upland game (grouse, partridge, pheasants or tree squirrels), fox or coyote and unprotected birds and animals are not required to possess the waterfowl license, nor are they restricted to zones. State law restricts nonresident small game hunters to specified days. Small game hunters may choose either option 1) statewide hunting for 14 consecutive days, OR option 2) statewide hunting for two periods of 7 consecutive days each. You may purchase more than one nonresident small game license per year. **Those wishing to hunt only waterfowl are not required to possess the small game license.** Crane hunters must possess **either** the small game license **or** the waterfowl license. State law restricts nonresident waterfowl hunters to zones (exception - statewide license) and specified days. Waterfowl hunters may choose either option 1) hunting in zone 3 only for 14 consecutive days or for two 7 consecutive day periods, OR option 2) hunting in zones 1 or 2 for 7 consecutive days and also hunting in zone 3 for 7 consecutive days, OR option 3) choosing either zones 1 or 2 and also selecting zone 3 for the same 7 day time period, OR option 4) purchasing the more expensive statewide license which allows statewide hunting for 14 consecutive days or for two 7 consecutive day periods.

National Migratory Bird Harvest Information Program (HIP): All migratory bird hunters **must** fill out information in box below. See explanation on back.

2. INSTRUCTIONS: General Information and Fees. Select licenses at right.
 (If you need any assistance in filling out this application, contact the N.D. Game & Fish Department.)

a) A fishing, hunting and furbearer certificate is required of all hunters prior to purchasing any other license. If you don't already have the certificate, you must purchase it at this time.

The general game and habitat license is required of all small game, crane and waterfowl hunters. The small game license is required of all small game hunters. **Either** the small game license **or** the waterfowl license is required of all nonresident crane hunters. To hunt waterfowl, you must purchase a state waterfowl license and (if 16 years of age or older) possess a federal Migratory Bird Hunting and Conservation Stamp (Duck Stamp). A nonresident hunting only fox, coyote and unprotected species of wildlife needs only a furbearer and nongame license. A nonresident hunting only unprotected species of wildlife (prairie dogs, rabbits, skunks, gophers) needs only a nongame license. Nonresident youth may qualify for reduced rate licenses (see back of application for details). Nonresident full-time college students may qualify for purchasing resident licenses (see back of application for additional information).

Send total for all licenses purchased. Do not send cash. Personal checks, cashier's checks or money orders are acceptable.

b) If applying for a small game license, you may hunt statewide but must choose specified days. Fill in the date(s) you desire for either option 1 or option 2 to the right.

c) If applying for a waterfowl license, see backside for map of waterfowl zones. Fill in the zone(s) and date(s) you desire for either option 1, option 2, option 3, or option 4 (statewide - no zones) to the right.

d) Fill in all information in the "Applicant Information Section." **ATTENTION! If you were born after December 31, 1961, you must fill in your hunter education certificate number and the state or province in which you received it. Required hunter education certification must be completed prior to application being submitted. ATTENTION: Compliance is enforced by verification with state enforcement agencies. If your certificate is unnumbered, write "none" and the year and state in which you were certified. If you have a change in last name since completing the course, attach a note to the application. Individuals qualifying for a one year apprentice hunter validation should visit our website at gf.nd.gov for more details.**

Your social security number must also be included. Please see back of application for additional information regarding the social security number requirement.

e) Sign and date the form after carefully reading section 3, below.

3. AS AN APPLICANT, I CERTIFY THAT:

- ... This is the only application being made in my name for a nonresident license (except for small game).
- ... All information provided is true and correct and I understand that providing false information may result in criminal prosecution;
- ... I am submitting with this application the appropriate fees;
- ... I am aware of the hunter safety education course requirement for persons born after December 31, 1961, and have passed an official state or provincial course (not required until age 12), or am exempt by law.

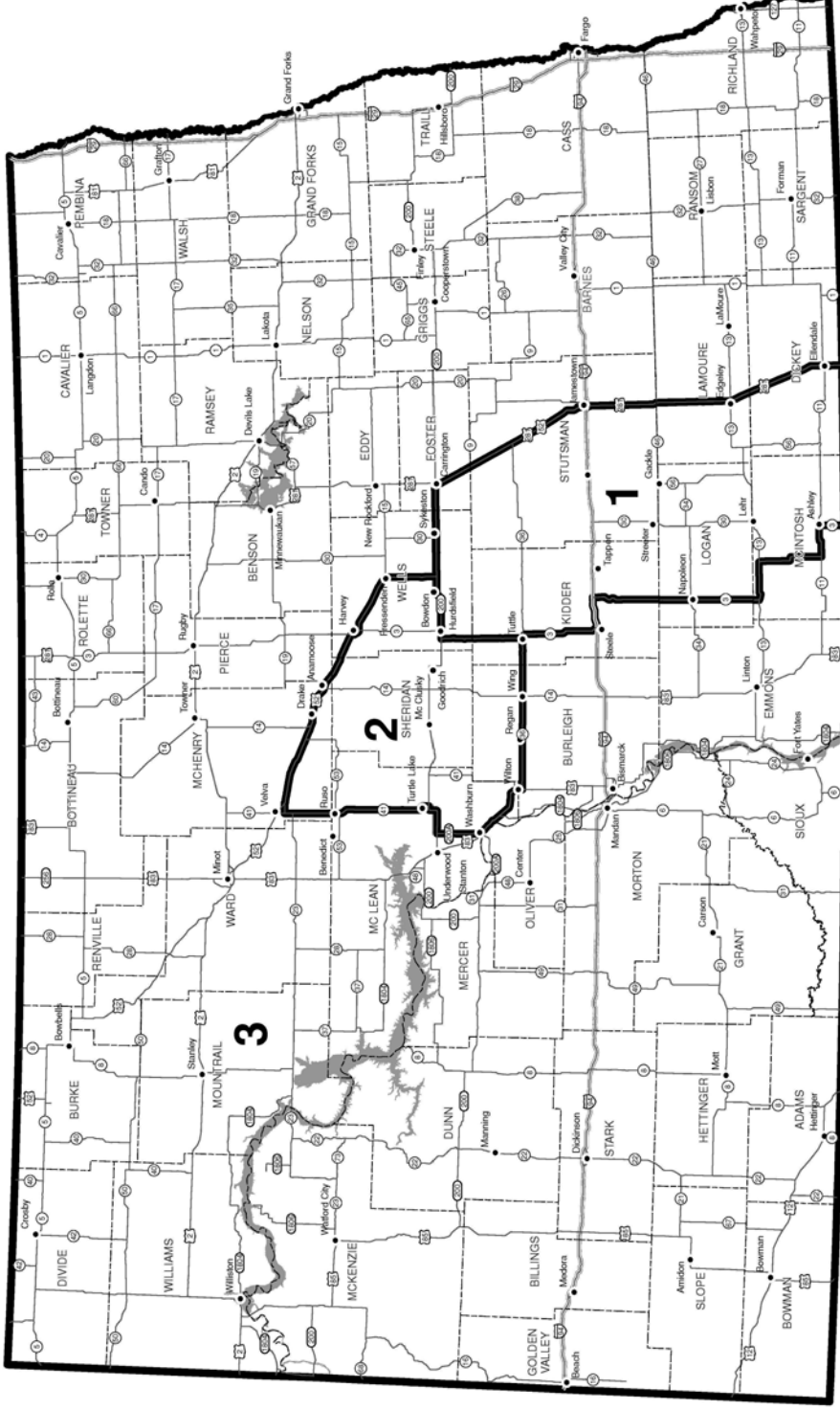

NONRESIDENT WATERFOWL ZONES



ZONE 1. U.S. Highway 281 from South Dakota to Jamestown; U.S. Highway 52 from Jamestown to Carrington; N.D. Highway 200 from Carrington to Hurdfield; and N.D. Highway 3 from Hurdfield to South Dakota.

ZONE 2. N.D. Highway 3 from Turtle to Hurdfield; N.D. Highway 200 from Hurdfield to U.S. Highway 52 east of Bowdon; north on U.S. Highway 52 to N.D. Highway 97 south of Velva; west on N.D. Highway 41; south on N.D. Highway 41 (south of Velva) to N.D. Highway 200 at Turtle Lake; west on N.D. Highway 200A to Washburn; and south on U.S. Highway 83 to Wilton.

ZONE 3. The remainder of the state.

Migratory Bird Harvest Information Program (HIP)

In addition to all appropriate state and federal licenses and stamps, participation in the Migratory Bird Harvest Information Program (HIP) and evidence of that participation is **required** to hunt migratory birds in North Dakota. A hunter may not hunt migratory game birds without being **HIP** certified in each state hunted. A hunter may receive **HIP** authorization by completing the information on this form or when purchasing a license through our 24-hour internet or phone licensing systems (See information at right). **HIP** was designed by the U.S. Fish and Wildlife Service to measure the harvest of migratory birds for management purposes. With your help, we can continue to protect migratory game birds and assure future hunting. Thank You!

NON-TOXIC (STEEL) SHOT REGULATIONS

Possession or use of shot other than federally approved non-toxic shot is prohibited while hunting ducks, geese, sandhill cranes, tundra swans, mergansers, snipe and coot statewide.

Non-toxic shot is required for hunting on all Fish and Wildlife Service lands, including Refuges and Waterfowl Production Areas. This regulation applies to all hunters using shotguns except while hunting turkeys and big game. These shot requirements are in addition to current statewide non-toxic shot requirements for migratory birds as listed above.

For additional information on non-toxic shot, contact the Department's Bismarck office.

Nonresident youth hunting licenses. A nonresident under age sixteen need only purchase a North Dakota resident fishing, hunting and furbearer certificate and a North Dakota resident general game and habitat license to hunt small game and waterfowl except swans and wild turkeys; **provided, that the nonresident's state, or province or territory of Canada, of residence provides a reciprocal licensing agreement for North Dakota residents who are also under age sixteen.** Currently states of CO, CT, ID, KY, MI, MN, MO, MS, NE, NJ, NY, OH, SC, TN, TX, and WI qualify. To be eligible, a nonresident youth may not have turned sixteen before September first of the year for which the license is issued and must possess a certificate of completion for a certified hunter education course. The nonresident youth may only hunt under the supervision of an adult family member or legal guardian who is licensed to hunt small game or waterfowl in this state and is subject to the same regulations as that youth's adult family member or legal guardian.

Nonresident full-time students living in North Dakota, **who are attending a state or tribal college, or a private institution of higher education,** may qualify for purchasing resident (non lottery) licenses. Please contact the Department for details.

Regular license fees apply with no service charge added. Applicants must print out their own license and those without a printer will receive a confirmation number to carry.

In addition to the license fee(s), a service charge will vary depending on amount of transaction.

SOCIAL SECURITY NUMBER REQUIREMENT. In accordance with state law NDCC 20.1-03-35 and 42 US Code 666 (a) (13) and (16), the Department is required to collect social security numbers from all persons obtaining hunting, fishing, or other recreational type licenses. Your social security number serves as your principal identification number to determine license eligibility. It is kept confidential, however it may be provided to law enforcement agencies and the State Disbursement Unit to enforce child support obligations.

The NDGFDD receives federal financial assistance from the US Fish and Wildlife Service.
