**SEASON DATES: November 9 (noon) through November 25, 2018**

State law allows a resident of North Dakota who is a member of the United States Armed Forces stationed outside this state, who shows proof of North Dakota residency, including a driver's license number or a nondriver photo identification number from this state, and who pays the appropriate licensing fee, to be issued a regular deer gun season license without having to participate in the lottery.

The 2018 governor's proclamation also provides that North Dakota residents who were on federal active duty with the U.S. Armed Forces under Title 10, stationed outside of the state during the 2017 deer gun season, and who received the expeditionary medal or campaign badge, and submit an application and appropriate license fee **by June 6, 2018, are eligible for one white-tailed deer gun license in the unit of their choice, without having to participate in the lottery. Applications received after June 6, 2018 will be issued licenses based on availability.**

**LICENSE FEE: \$30.00.** Please mail a check or money order in addition to your military documents described below to the address at the top of this form.

**ELIGIBILITY:** Please make sure you meet all the eligibility requirements listed below, including age and hunter education requirements. Only one application per person may be submitted. There are no provisions to apply as a party. **In accordance with state and federal laws, you must include your Social Security Number and a valid North Dakota driver's license number or North Dakota nondriver photo ID number.**

Please check one of the following, making sure you meet **all** eligibility requirements listed for whichever type of military deer license you are applying for.

- I certify that I am a legal North Dakota resident and am a full-time, active duty member of the U.S. Armed Forces and stationed outside the state. I have completed all the information below and have supplied a valid North Dakota driver's license or North Dakota nondriver photo ID number. I have also supplied appropriate military documents showing ND as my home of record, active duty status, and duty station outside the state.
- I certify that I am a legal ND resident and was on federal active duty with the US armed forces under Title 10, stationed outside of the state during the 2017 deer gun season, and received the expeditionary medal or campaign badge. I have completed all the information below and have supplied a valid ND driver's license or ND nondriver photo ID number. I have also supplied appropriate military documents showing the dates of my deployment under Title 10, as well as the above decorations received.
