Organizations must be exempt from federal income taxation under section 501(c)(3) and must provide a copy of the letter from the Internal Revenue Service to that effect. Organizations must also be active and in good standing in the office of the North Dakota Secretary of State. Pursuant to NDCC 20.1-05.1-02(5C), successful lottery applicants must agree to donate at least 10 percent of the net proceeds of any license raffle to a conservation-related project including, but not limited to, hunting access, conservation education, habitat development and shooting range management. *(Proceeds may also be sent to the North Dakota Game and Fish Department for a conservation project chosen by the Department.)*
