
RULES FOR ARCHERY HUNTING ON SPECIFIED CITY PROPERTIES

- 1. All laws and regulations established by the state of North Dakota and the city of Bismarck shall be enforced in hunting areas, except those that by their nature are not applicable.
- All archers must apply and receive a trespass permit from the Bismarck Police Department before participating in the special archery hunt. The trespass permit authorizes archers to hunt on specified city properties during specific time periods (map 1). All trespass permits must be carried by archers while hunting. Permits must be displayed upon demand by any enforcement officer of the state of North Dakota. A valid North Dakota hunting license and archery stamp are also prerequisites.
 Archers may hunt any deer from August 31, 2012, at noon through January 6, 2013 and, for does, only from
- 3. Archers may hunt any deer from August 31, 2012, at noon through January 6, 2013 and, for does, only from January 7, 2013 through January 31, 2013. A special license is required to hunt in January. Archers may hunt wild turkeys from October 13, 2012 through January 13, 2013.
- 4. Archers can't hunt in safety zones, but can establish themselves alongside the zones and shoot back into allowable areas. No hunting is allowed in or around occupied buildings or properties in any of the hunting areas.
- 5. Hunting from tree stands is permissible, provided the stands are portable and that the stand or steps do not damage trees in any way. Use of any type of permanent stand, old or new, is prohibited.
- 6. Deer drives are not allowed for safety reasons.
- 7. Cutting trees or brush is prohibited.
- 8. No vehicles are allowed inside hunting areas at any time.
- 9. Hunters must park vehicles only in designated parking areas. Archers not complying may have their permits revoked. Designated parking areas are as follows:
 - a. Archery range Use the range lot.
 - b. Waste water plant Use the southwest corner of the archery range lot, or park by the main gate to the water plant on London Avenue.
 - c. Airport Park to the side of the gate as there are people living there. Do not block the gate. The hunting area is on the west side of the creek.
- 10. The tree nursery area and open hay fields adjacent to the waste water treatment plant are closed to hunting.
- 11. Archers receiving a trespass permit under the program may purchase up to three doe-only licenses from the North Dakota Game and Fish Department, and only one turkey tag (maximum of 25 available).
- 12. Archers must wear hunter orange if hunting during portions of the deer gun season. There are no clothing restrictions for the remainder of the archery season.
- 13. Mandatory questionnaires must be completed at the end of your hunting period and returned to the Bismarck Police Department at 700 S. 9th St., Bismarck, ND 58504. Mark questionnaires as accurately as possible. Return questionnaire deadline is February 14, 2011.
- 14. This archery program is experimental from year-to-year and can be terminated at any time.
- 15. Selected archers are ambassadors of the archery program. Its continuation depends on you. We ask that there be no smoking in the field, to report violators, police your ranks, strive for compatibility with other users, think safety and enjoy yourself. Use common sense when removing your game from hunting areas.
- 16. The number of permits for city properties is limited to 50.

BISMARCK CITY ARCHERY SHOOTING AREAS

- 1. **Behind Horse Barn Area:** Park in the archery range parking lot. Walk in from the bike trail out of site of trail users. Follow the walking path in on south side until you reach the orange flag tape. You must remain on east side of tape and shoot only into the hunting area (east of tape) and not back in to horse barn area. Where the orange flag line meets the fence by the drainage ditch to the south, the drainage ditch becomes the west boundary to Burleigh Avenue. From the flagging area on the walking trail, the walking trail is the boundary to the east. Stay far enough in the woods to not be seen from walking trail. (See Maps 1 and 2.)
- 2. Archery Range Area: Park in the archery range parking lot. Walk outside the range fence between the walking trail and archery range fence to the area where the fence turns north. You can hunt the area from there to the golf course fence, then east to orange flag line on the meadow. This flag line follows the meadow back to the walking path. No shooting out of hunting area along the boundaries. All shooting is to be back into hunting area within the edges of the boundaries. (See Map 2.)
- 3. Water Treatment Plant Area: Follow London Avenue into the water treatment plant area and park in the grass near the dumpster recycling area. Park so others can access the dumpsters while you are hunting. You can also park at the gate on Burleigh Avenue and England Street. If you park there, make sure to stay clear of the walking trail. The boundaries for this area are as follows: From the edge of the field on London Street as you enter the water treatment plant land there is a cut firebreak road north to the drainage ditch and south to Burleigh Avenue, this is the west boundary. Where the north firebreak meets the drainage ditch, the drainage ditch going to the west becomes the boundary. That portion of Burleigh Avenue from the firebreak to English Street forms the south boundary. Twenty to 50 yards in from the bike trail running east and west is flagged with orange marker tape. The firebreak is also flagged with orange marker tape. You must be inside the flagged area and when close to boundaries, shoot only into hunting area. The hay flats on water treatment plant are not open to hunting. (See Map 2.)
- 4. **Airport Area:** In the vicinity of Lincoln Road and Airway Avenue, park on inside gate on corner of Airway Avenue, but don't block gate or road as some people live down the road across the creek. You can also park on the corner of Lincoln Road and Airway Avenue. The west boundary is marked with orange flagging tape. The east boundary is the creek. (*See Map 3.*)
- 5. **Private Property Area in South Bismarck** (yellow area on Map 1): This area does not require a city permit, but does require landowner permission. Unlimited Burleigh County herd reduction licenses for the yellow area are available through the North Dakota Game and Fish Department. All Game and Fish Department permits are \$20 for adults and \$10 for youth under 16 (See Map 1).
